<u>N O T I F I C A T I O N</u> Imphal, the 27th September, 2024

No. 7/3/2020-MPSC (DR): On the basis of the written examination for recruitment to 300 posts of Medical Officer (MHS Gr-IV) held on 10th May 2022 and interview conducted from 3rd to 10th May, 2024 124 (one hundred and twenty four) candidates were recommended for appointment to the post of Manipur Health Services Gr-IV (Medical Officer) in the Health Department, Govt. of Manipur. In compliance of Hon'ble High Court of Manipur's order dated26.04.2024 passed in WP(C) No. 284 of 2024 with MC(WP(C) No. 254 of 2024, 3(three) petitioners bearing Roll Nos. 10665, 10712 and 11229 were allowed to appear for the Interview but results were kept withheld and could not be declared without the leave of the Court.

2. The Hon'ble High Court of Manipur in its order passed in MC(WP(C) No. 296 of 2024 with MC(WP(C) No. 254 of 2024 dated 22.07.2024 with WP(C) No. 284 of 2024 dated 21.08.2024 had directed that "the Director of Health Services shall forward a copy of the proceedings of the Committee along with its view to the Secretary, MPSC within a period of two weeks from today (21.08.2024) and upon receipt of the reports of the from the Administrative Department, MPSC shall take a decision within one month from the date of receipt of report from the Administrative Department".

3. The Director of Health Services, Govt. of Manipur submitted the proceedings of the Committee vide its letter No. G(WP(C) No. 284 of 2024-DHS/1869 dated 6th of September, 2024 in response to MPSC's letter No. 7/3/2020-MPSC(DR) dated 3rd of September, 2024 and observation of the Committee is given in Para 5 of the proceedings which verified the COVID experience certificate of the three candidates to be genuine.

4. In Compliance of the of the Order the Hon'ble High Court dated 21.08.2024 passed in the above MC(WP(C) No. 296 of 2024 with MC(WP(C) No. 254 of 2024 dated 22.07.2024 with WP(C) No. 284 of 2024, the Commission has awarded 10 marks for COVID duty experience to the 3(three) candidates and opened the sealed cover of the interview results and the final result in respect of these candidates is as under:

1. Roll No. 11299 (Dr. Fahmina Halim) obtained the qualifying marks of 40% for UR & OBC (i.e. 80 marks out of 200 marks) in the written exam. Hence, she is recommended for appointment to the post of Manipur Health Service Grade-IV (Medical Officer). She shall be placed below SI. No. 62 and above SI. No. 63 of the Commission's Notification No. 7/3/2020-MPSC (DR) dated 10th May, 2024

2. Roll No. 10712 (Dr. Khullar Kamnong) obtained the qualifying marks of 35% for ST (i.e. 70 marks out of 200 marks) in the written exam. Hence, he is recommended for appointment to the post of Manipur Health Service Grade-IV (Medical Officer). He shall be placed below Sl. No. 118 & above Sl. No. 119 aof the Commission's Notification No. 7/3/2020-MPSC (DR) dated 10th May, 2024

3. Roll No. 10665 (Dr. Thokchom Nirjanta Devi) failed to obtain qualifying marks of 40% for UR & OBC (i.e. 80 marks out of 200 marks) in the written exam and thus interview marks are not relevant. Hence she is not recommended for appointment to the post of Manipur Health Service Grade-IV (Medical Officer).
