No. 8/1/2012-DR/DP (Pt.III): In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Manipur hereby makes the following Rules further to amend the existing Jr. Manipur Civil Service Rules, 2007 namely:

1. SHORT TITLE AND COMMENCEMENT
 - (a) These Rules may be called the Jr. Manipur Civil Service (1st Amendment) Rules, 2016;
 - (b) These rules shall come into force with effect from 15.12.2012 retrospectively.

2. AMENDMENT OF SCHEDULE- I:

For the existing Schedule-I to the Jr. Manipur Civil Service Rules, 2007 as amended from time to time, the following shall be substituted namely:-
