## NOTIFICATION Imphal, the 18<sup>th</sup> October, 2017

**No. 7/16/2014-MPSC (DR):** The Government of Manipur vide its letter No. Writ/11/61/2014-HE/Case dated 16.09.2017 communicated its decision to restrict the reservation to 50% of the total posts of Assistant Professor in Government Colleges advertised for recruitment in compliance of the orders dated 11.01.2017 passed by the Hon'ble High Court in WP (C) No. 993 of 2014, WP (C) No. 356 of 2016, WP (C) No. 708 of 2016, WP (C) No. 1019 of 2015 and WP (C) No. 270 of 2016. Changes in the category-wise vacancies have been made in respect of 13 subjects while keeping the total vacancies for the subject unchanged. The new category-wise vacancies in respect of the 13 subjects are as below:

2. The Commission vide its notification of even number dated 26.09.2017 issued a list of candidates who would be called for interview in view of the increase in unreserved vacancies, etc. The methodology to determine the additional candidates is as follows:

All those candidates who are within twice the number of unreserved vacancies in the merit list of the screening test for the subject shall be called for the interview provided that the candidates has not faced the interview earlier.

In case of subjects where there is an increase in OBC (M) or OBC (MP) vacancies, then additional candidates equal to twice the increase number of OBC (M) or OBC (MP) whichever is applicable would be called in addition to additional candidates being invited for the unreserved vacancies.

3. The Commission while notifying the list of candidates, found qualified for interview based on the screening test, on 03.12.2015 treated vacancies of each category as a separate entity and shortlisted candidates twice the number of vacancies for each category irrespective of number of ST/ OBC (M)/ OBC (MP)/ OBC (O) candidate in the candidates shortlisted for the unreserved vacancies.

- 4. Since the interview process of additional candidates is a continuation of the same recruitment, the Commission has decided to continue with the methodology to shortlist candidates for interview adopted earlier. Accordingly, the new list of candidates to be called for interview and reasons for doing so in respect of each subject is as below:
  - (i) Chemistry: Earlier top 2 candidates were called for the 1 unreserved vacancy. Now, unreserved vacancy has increased to 7, so the first 14 needs to be called. Out of that, 7 candidates have already faced interview. For the 2 OBC (M) vacancies, 4 OBC (M) candidates below rank 14 are to be called. No OBC(M) candidate below rank 14 has faced interview earlier. For 5 ST vacancies, 10 ST candidates below rank 14 are to be called. 7 ST candidates below rank 14 have already faced interview. No other ST candidate who has secured the qualifying mark is available. Accordingly, the following additional candidates are called for interview:

(ii) Computer Science: Earlier top 5 candidates (equal mark) were called for the 2 unreserved vacancies. Now, unreserved vacancy has increased to 4, so the first 8 needs to be called. Out of that, 7 candidates have already faced interview. For the 1 OBC (M) vacancy, 2 OBC (M) candidates below rank 8 are to be called. No OBC(M) candidate below rank 8 has faced interview earlier. For 1 ST vacancy, 2 ST candidates below rank 8 are to be called. 2 ST candidates below rank 8 have already faced interview. Accordingly, the following additional candidates are called for interview:

(iii) Economics: Earlier top 9 candidates (equal mark) were called for the 4 unreserved vacancies. Now, unreserved vacancy has increased to 10, so the first 21 (equal mark) needs to be called. Out of that, 18 candidates have already faced interview. For the 3 OBC (M) vacancies, 6 OBC (M) candidates below rank 21 are to be called. No OBC (M) candidate except Roll No. 11279 (under DAP) below rank 21 has faced interview earlier. For 5 ST vacancies, 10 ST candidates below rank 21 are to be called. 15 ST candidates below rank 21 have already faced interview. Accordingly, the following additional candidates are called for interview:

(iv) Education: Earlier top 12 candidates (equal mark) and Roll No. 10872 (under DAP) were called for the 5 unreserved vacancies. Now, unreserved vacancy has increased to 10, so the first 21 (equal mark) excluding candidates with M.Ed. degree in compliance of Hon'ble High Court's order date 28.03.2017 passed in WP (C) No. 1020 of 2015 needs to be called. Out of that, 17 qualified candidates have already faced interview. For the 3 OBC (M) vacancies, 6 OBC (M) candidates below rank 21 are to be called. No OBC(M) candidate below rank 21 has faced interview earlier. For 4 ST vacancies, 8 ST candidates below 21 are to be called. 9 ST candidates below rank 21 have already faced interview. Accordingly, the following additional candidates are called for interview:

(v) English: Earlier top 20 candidates were called for the 10 unreserved vacancies. Now, unreserved vacancy has increased to 23, so the first 46 needs to be called. Out of that, 35 candidates have already faced interview including Roll No. 10130 (DAP). For the 4 OBC (M) vacancies, 8 OBC (M) candidates below rank 46 are to be called. No OBC(M) candidate except Roll No. 10214 (under DAP) below rank 46 has faced interview earlier. (vii) History: Earlier top 8 candidates and Roll No. 10940 (under DAP) were called for the 4 unreserved vacancies. Now, unreserved vacancy has increased to 7, so the first 15 (equal mark) needs to be called. Out of that, 14 candidates have already faced interview. (ix) Mathematics: Earlier top 14 candidates were called for the 7 unreserved vacancies. Now, unreserved vacancy has increased to 16, so the first 32 needs to be called. Only 20 candidates have secured the minimum qualifying marks. Out of these 20, 17 candidates have already faced interview. For the 3 OBC (M) vacancies, 6 OBC (M) candidates below rank 32 are to be called. No OBC (M) candidates are available. For 6 ST vacancies, 12 ST candidates below rank 32 are to be called. No ST candidates are available. For the 2 OBC (MP) vacancies, 4 OBC (MP) candidates below rank 32 are to be called. No OBC (MP) candidates are available.
