No. 7/16/2014-MPSC (DR): The Higher Education Department, Government of Manipur vide its letter No. 7(2)/9/2005-S-HE(Pt-II) dated 29.10.2014 sent a requisition for direct recruitment of 285 Assistant Professor of various Government Colleges. The letter indicated the number of posts available for each subject and the reservations for different categories within the subject. In pursuance of this letter this Commission issued a notification dated 15.11.2014 inviting applications for 280 posts of Assistant Professors and conducted a Screening Test on 27.10.2015. Based on the performance in the written test, candidates were invited for the interview keeping the number of vacancies and reservations for the various categories into consideration. The Academic Records of the shortlisted candidates were evaluated in consultation with UGC.

2. During this process, Writ Petition (C) No. 993 of 2014 and some others was filed challenging the reservations made for various categories. The Hon'ble High Court in a common judgement dated 11.01.2017 directed the State Government to restrict the reservation to 50% of the total posts.

3. The State Government vide its letter No. Writ/11/61/2014-HE/Case dated 16.09.2017 furnished a revised list of vacancies reserved for various categories. The Department has not changed the reservation in respect of subjects where there were no unreserved vacancies earlier. The revised list furnished by the Government was examined and found that the unreserved vacancies have increased substantially. Therefore, the number of candidates who were invited earlier against the unreserved vacancies is not adequate as it would be far short of the earlier process to consider candidates twice the number of vacancies. Candidates who have faced the interview earlier need not be invited for the interview again.

4. In view of the above, the candidates listed below in respect of each subjects are informed that the interview is tentatively scheduled in the 3<sup>rd</sup>-4<sup>th</sup> Week of October, 2017 and also to submit documents relating to Academic Record if not submitted earlier:
