
- iv) Head Masters of Junior High Schools with Postgraduate Degree in any Discipline and B.Ed. with 10 years of regular service.

Period of probation : 2 (two) years.

Duties : To supervise and monitor the functioning of the schools in terms of the provisions of the Right to Education Act, 2009, to supervise the implementation of the Mid Day Meal Scheme, and to assist the superior inspecting staff of the Department.

1. The prescribed application form, scheme of examination can be obtained on payment of 100/- at the Commission's Counter from **25-07-2014** during officer hours. However, syllabus for the examination will be available in www.mpscmanipur.gov.in.
2. Last date for issue and receipt of duly filled in application form is **25.08.2014**.
3. **Examination Fee :** ₹ 200/- for General and OBC; ₹ 50/- for SC/ ST in cash only (any other form of payment is not accepted) should be submitted along with the application form at the counter of MPSC.
4. Lost/ delay in submission of forms due to postal service will not be the responsibility of the Commission and no claim on such matter will be entertained under any circumstances.
5. Date of examination/ interview will be notified later on.
6. The decision of the Commission as to the eligibility or otherwise of the candidate shall be final.
