Class/ Group	:	Group-C
No. of Post	:	8 (eight) [3-UR, 3-ST, 1-OBC (M), 1-OBC(MP),] <i>[Note: The number of posts may be increased or decreased at the discretion of the Government]</i>

**Essential Qualifications:-**

1. Degree in Arts/ Science/ Commerce securing 55% in aggregate from a recognised university.
2. Minimum 6 months certificate course on basic computer knowledge conducted by DOEACC or C-DAC or equivalent.

**Age:** -38 years and below as on 1<sup>st</sup> of July, 2014. Further, the upper age limit is relaxable by 5 years for SC/ST and 3 years for OBC. Upper age limit is relaxable for Government servants appointed under the Government of Manipur to the extent of the period of continuous service put in the post/ service and Government servant who belongs to SC/ ST/ OBC will get the facility admissible to a Government servant in addition to the relaxation admissible to SC/ ST/ OBC candidates.

**Probation:** 2 (two) years.

**Duties:** Inspection and checking of dealer's file, accounts books, etc..

**Note:-**

1. The prescribed application form can be obtained on payment of ₹ 100/- at the Commission's Counter from **25.07.2014**.
2. Last date for issue and receipt of duly filled in application form is **25.08.2014**.
3. **Examination Fee:** ₹ 200/- for General and OBC; ₹ 50/- for SC/ ST in cash only (any other form of payment is not accepted) should be submitted along with the application form at the counter of MPSC.
4. Lost/ delay due to postal service will not be the responsibility of the Commission and no claim on such matter will be entertained under any circumstances.
5. Date of examination/ interview will be notified later on.
6. The decision of the Commission as to the eligibility or otherwise of the candidate is final.
