No. 7/1/2017-MPSC (DR): Whereas, recruitment for the 9 (nine) posts of Homeopathic Physician and 3 (three) posts of Ayurvedic Physician was advertised on 21.07.2017 and the written test conducted on 30.08.2017.

2. Whereas, the Hon'ble High Court by its order dated 25.08.2017 passed in WP (C) No. 644 of 2017 directed that the result of the selection process shall not be declared without the leave of the Court.

3. Whereas, the State Government vide its letter No. 18/60/2017-M(C) dated 06.09.2018 intimated that the Hon'ble High Court has in Misc Case [WP (C)] No. 178 of 2018, Ref. WP (C) No. 641 of 2017 passed order dated 31.08.2018 allowing declaration of the result of the recruitment process subject to the outcome of the WP (C) No. 641 of 2017.

4. And whereas, the Government has also informed that the State Government Counsel (High Court) in his letter dated 09.05.2018 intimated the Government that the Hon'ble High Court has disposed off WP(C) NO. 644 of 2017 as the writ petition has been withdrawn.

5. Now, therefore, on the basis of the result of the written examination for recruitment to the post of Manipur Health Service Grade-IV (Homeopathic Physician and Ayurvedic Physician) held on 30.08.2017, candidates with under mentioned Roll Numbers are found qualified for Personality Test/ Interview:
