NOTIFICATION Imphal, the 22nd October, 2024

F.No. 7/10/2022-MPSC (DR) (Vol.II): In compliance of the order of the Hon'ble High Court of Manipur dated 16/10/2024 passed in W.P.(C) No. 723 of 2024 with MC(WP(C)) No. 613 of 2024 the window for online updation will be open for 2 (two) days (48 hours) from 05:00 p.m. of 23/10/2024 till 05:00 p.m. of 25/10/2024 to allow the petitioners to update the following details along with payment of requisite fees, through the link https://empsconline.gov.in/MCSCCE2022/verifyapplicant.aspx.

- a) Mobile number & email address.
- b) Postal Address.

There are also some candidates who had approached the Commission for allowing them to update their details as they had missed the deadline due to various reasons.

In the interest of natural justice and equity, these similarly placed candidates are also permitted to avail of the chance to update their details within this window period on the same terms and conditions as laid down in the Hon'ble High Court's order dated 16/10/2024 passed in W.P. (C) No. 723 of 2024 with MC(WP(C)) No. 613 of 2024. It may also be noted by these candidates that their permission to appear in the examination is subject to the same terms and conditions as directed by the Hon'ble High Court dated 16/10/2024 which amongst others, states that "the petitioner is permitted to update his credentials and make payment, if any, with respect for the appearance in the main examination subject to the outcome of the writ petition".

It is made clear that they are not placed on the same footing as those candidates who had submitted their application details in time. A copy of the Order of the Hon'ble High Court dated 16/10/2024 is enclosed along with this notification.

Applications from candidates whose details are not updated within this window period of 2 (two) days (48 hours) will not be entertained.

[1] Heard Mr. M. Hemchandra, learned senior counsel assisted by Mr. M. Rendy, learned counsel appearing on behalf of the petitioner.

The petitioner who is the candidate in the Manipur Civil Services Combined Competitive(Preliminary) Examination, 2022 was declared successful in the preliminary examination. However, as he was in Ladakh for a period from 24.06.2024 to 12.08.2024 in connection with some projects he could not update his details in the Manipur Public Service Commission (MPSC) website in pursuance to the notification dated 09.07.2024 and 06.08.2024 issued by the Controller of the MPSC. Accordingly, he has submitted a representation dated 08.10.2024 to the Chairman of MPSC for consideration of non-submission of his credentials and payment for the purpose of appearing in the main examination.

- [3] Since the request has not been acceded to the petitioner approached this Court by way of the present writ petition praying for a direction to consider his representation dated 08.10.2024 and also allow him to submit his credentials.
- [4] Issue notice.
- [5] Ms. Nikita, learned counsel assisting Mr. M. Rarry, learned senior counsel accepts notice on behalf of respondent Nos.1 & 3 and Mr. Dinesh Tokpam, learned counsel assisting Mr. RK Deepak, learned senior counsel accepts notice on behalf of respondent No.2.
- [6] Mr. M. Hemchandra, learned senior counsel appearing for the petitioner submits that the reason for not able to submit his credentials in the MPSC website was due to his engagement in the project in the remote area of Ladakh where communication is very poor and during the pendency of the present writ petition, as an interim measure, he may be permitted to update his details and made payment, if required.
- [7] Mr. RK Deepak, learned senior counsel for the MPSC submits that he may be given some time to take instruction in this regard.
- [8] This Court has considered the materials on record for the purpose of consideration of interim relief. It may be noted that in the batch of the writ petitions, this Court has allowed the updation of the details of the petitioners who have been declared unsuccessful

in the preliminary examination on the ground that they could have been successful if the mark had been allotted with respect to few questions.

[9] In the present case, the petitioner is not alleging any lapses on the part of the MPSC but he is praying for allowing him to update his credentials sympathetically, as he could not do the same due to engagement in some project in remote area.

[10] Considering the facts of the present writ petition, the petitioner is permitted to update his credentials and made payment, if any, with respect for the appearance in the main examination subject to the outcome of the writ petition."
