NOTIFICATION

Imphal, the 14th February, 2023

No. 7/10/2022-MPSC(DR): In continuation of this Commission's notification dated 13th March, 2019, it is hereby informed to all concerned candidates of Manipur Civil Services Combined Competitive (Preliminary) Examination, 2019 that blind candidates and candidates with Loco-motor Disability and Cerebral Palsy where dominant (writing) extremity is affected to the extent of slowing the performance of function (minimum of 40% impairment) will be allowed to write the examination with the help of a scribe in both the Civil Services (Preliminary) as well as in the Civil Services (Main) Examination.

2. That, compensatory time of twenty minutes per hour shall be permitted for the Blind candidates and the candidates with loco-motor disability and cerebral palsy where dominant (writing) extremity is affected to the extent of slowing the performance of function (minimum of 40% impairment) in both the Civil Services (Preliminary) as well as in the Civil Services (Main) Examination.

3. That, the eligibility conditions of a scribe, his/ her conduct inside the examination hall and the manner in which or extent to which he/she can help the blind candidate in writing the Civil Services Examination shall be governed by the instructions issued by the MPSC in this regard. Violation of all or any of the said instructions shall entail the cancellation of the candidature of the blind candidate in addition to any other action that the MPSC may take against the scribe.

4. Further, for purpose of these rules the candidate shall be deemed to be a blind candidate if the percentage of visual impairment is Forty per cent (40%) or more. The criteria for determining the percentage of visual impairment shall be as follows:—

Category	All with corrections		Percentage
	Better eye	Worse eye	
Category O	6/9 – 6/18	6/24 to 6/36	20%
Category I	6/18 – 6/36	6/60 to nil	40%
Category II	6/60 – 4/60 Or field of vision 10° – 20°	3/60 to nil	75%
Category III	3/60 – 1/60 Or field of vision 10°	F.C. at 1 ft to nil	100%
Category IV	F.C. at 1 ft to nil field of vision 100°	F.C. at 1 ft to nil field of vision 100°	100%
One eyed person	6/6	F.C. at 1 ft to nil	30%

5. However, the concession admissible to blind candidates shall not be admissible to those suffering from Myopia.

6. Therefore, for availing the concession mentioned above, eligible candidates are informed to submit the following documents to the email mpscdrsection@gmail.com on or before **11:59 P.M of 19th February, 2023.**


A) Documents required to avail 20 minutes compensatory time of twenty minutes per hour:

- a). Disability certificate in the prescribed proforma from a Medical Board constituted by the State Governments
- b). Annexure-I (Certificates regarding physical limitation in an examinee to write) (**Only for persons with loco-motor disability and cerebral palsy**)

B) Documents required to avail Scribe:

- a) Photo of scribe.
- b) Signature of Scribe.
- c) Certificate of Highest qualification of Scribe.
- d) Disability certificate in the prescribed proforma from a Medical Board constituted by the State Governments
- e) Annexure-I (Certificates regarding physical limitation in an examinee to write)
- f) Annexure-II (Letter of Undertaking for using own scribe)

7. However, in case the candidate had availed scribe in the online application but do not submit the documents mentioned in para 6(B) above, it will be assumed that the candidate prefer the Scribe to be provided by the Commission.
