**No. 7/4/2021-MPSC (DR):** In continuation of this Commission's Notification of even number dated 27/08/2024 & 24/09/2024, it is hereby informed that the written examination for recruitment to the post of Assistant Research Officer in Planning Department, Manipur on contractual basis will be held on 14<sup>th</sup> December, 2024 at the Examination Hall of MPSC.

2. Provisionally eligible Candidates may download their e-admit card from the link <https://empsonline.gov.in/downloadadmitcardv2.aspx> w.e.f. 11:00 A.M. of 30<sup>th</sup> November, 2024 till 11:59 PM of 13<sup>th</sup> December, 2024.

3. No candidate will be allowed to take the examination unless he/she holds an e-Admit card for the examination. No candidate will be allotted to appear for the examination in any other venue than the one mentioned in the e-Admit Card. Entry into the examination Centre/Venue shall be closed 10 minutes before the scheduled commencement of the examination.

4. Candidates are instructed to visit their respective examination centre one day ahead of the examination to familiarize with the location of their examination centre to avoid last minute rush on the day of the examination as gate closure time will be strictly followed.
