 The written question would consist of 1 (one) paper of 100 nos. of Multiple Choice Type Question each carrying 1 mark for correct answer with a total of 100 questions.

- ii. The duration of test will be 3 hours.
- iii. There shall be no negative marking for incorrect answers or questions not attempted.
- iv. Questions will be of Matriculation level.

#### 3. Schedule of Examination

- (A) For the post of **Driver**, the Driving Test for the provisionally eligible candidates will be held at **Institute of Driver Training & Research Centre (IDTRC)**, Yaralpat, **Imphal East from 11:30 a.m. onwards of 23<sup>rd</sup> September, 2024** The provisionally eligible candidates for the post of Driver are informed to report at Institute of Driver Training & Research Centre (IDTRC), Yaralpat, Imphal East at 10:00 a.m. of 23<sup>rd</sup> **September, 2024** along with original documents and photocopies of Matriculation Certificate, Matriculation Marksheet, valid Driver Licences and Permanent Residential Certificate. Candidates not in possession of the said documents will not be allowed to appear for the Driving Test.
- (B) For the post of **Peon/ Chowkidar/ Security Guard**, the provisionally eligible candidates will be issued an e-Admission Certificate. The e-Admission Certificate will be made available in the MPSC website (www.empsconline.gov.in) for downloading by the candidates from **23<sup>rd</sup> September**, **2024**. No admission Certificate will be issued from MPSC Office or sent by post or any other means. The date of the written examination will be notified in due course.
- NOTE: If any provisionally eligible candidate for the post of Peon/ Chowkidar/ Security Guard has any difficulty in appearing for the examination at Imphal, it may be intimated to the Commission mentioning the name of provisionally eligible candidate and his online application number at email <a href="mailto:manipurpsc@live.com">manipurpsc@live.com</a> latest by 22nd September, 2024 (i.e., before issue of Admit Card). Any email received in this regard after 22nd September, 2024 will not be entertained. Email received from any person other than the provisionally eligible candidate will not be entertained.
- 4. Candidature of these candidates is provisional subject to their being found eligible in all respects. The candidates will be required to produce the original certificates in support of their claims pertaining to age, educational qualifications, community, other documents before the examination. They are, therefore, advised to keep the said documents ready with them.
