PART – I

GENERAL ADMINISTRATION

1.1. INTRODUCTION

1.1.1 The Manipur Public Service Commission constituted in pursuance of Article 315 of the Constitution of India, has been functioning at Imphal since the year, 1972.

1.2 DUTIES AND FUNCTIONS :

1.2.1 Article 320 of the Constitution requires the Commission to conduct examinations for appointment to various services of the State of Manipur. The Commission is also required under the Constitution to be consulted on :-

- (a) Matters relating to methods of recruitment to Civil Services and Civil Posts;
- (b) The principles to be followed in making appointment to Civil Services and posts and in making promotion and transfers from one service to another and on suitability of candidates for such appointment, promotion or transfers;
- (c) Disciplinary matter affecting persons serving under the State Government and civil including related memorials or petitions;
- (d) Any claim payable, out of the Consolidated Fund of the State, to a person serving under the State Government in Civil capacity, towards the cost incurred by him in defending legal proceedings instituted against him for acts done or purported to have been done in execution of his duty; and
- (e) Claims for award of pension in respect of injuries sustained by a person while serving under the State Government in Civil capacity and any question as to the amount of such award.

1.3. THE COMPOSITION OF THE COMMISSION :

1.3.1 Under Regulation No. 4 of the Manipur Public Service Commission Regulations, 1972, the Commission shall consist of a Chairman and 2(two) Members who are appointed by the Governor. The incumbents during the period i.e. 2016-2017 are as under :-

1. Shri Dilip Sinha, IFS(Retd) - Chairman

Shri Shyam Lal Poonia, IAS assumed as Secretary of the Commission during the period of 2015-2016. The Secretary is assisted by 13(thirteen) subordinate Group-A officers, 8(eight) Group-B, 20(twenty) Group-C and 28(twenty eight) Group-D staff during the year. 1.4 A – INCOME :

1.4.1 The Commission could get Rs.12,15,148/-(Rupees twelve lakh fifteen thousand one hundred forty eight) only from sale of application forms and realization of fees.

1.4.2 B-EXPENDITURE :

Total expenditure incurred by the Commission including salaries is Rs. 4,33,65,342 (Rupees four crore thirty three lakh sixty five thousand three hundred and forty two) only during 2016-2017.

The Commission received **1760** letters/correspondences from Government and non Government organization/individuals and issued **674** letters during 2016-2017.

1.6 **MEETING OF THE COMMISSION :**

The Full Commission held sittings to dispose of cases relating to Recruitment Rules, Promotion cases, Direct Recruitment cases, Limited Departmental Examinations, Limited Stenographers' Grade-I Examination.

PART – II

DIRECT RECRUITMENT CASES (2016-2017)

2.1.1 During the period 2016-2017, the Commission received **12** (twelve) fresh recruitment proposals from various departments. Out of which, the Commission conducted **2** (two) recruitment cases, *viz.* Manipur Civil Services Combined Competitive Examination and Scientific Assistants, which altogether account for **92** vacancies of different categories of posts and services. The recruitment of 2(two) posts for Scientific Assistant (Toxicology) was withheld by the court order. Also, the final result of 1 (one) proposal pertaining to 2014-15 case i.e. MES Grade II & III which was previously withheld by the court was declared in the current year thereby filling up **109** vacancies in the Higher Education Department. Since the post of Hon'ble Chairman is vacant, the remaining 10 (ten) proposals which altogether account for 147 vacancies of different categories of posts and services are still in their initial stage with notification yet to be notified.
