**No. 7/1/2021-MPSC (DR):** In continuation of this Commission's Notification of even number dated 6<sup>th</sup> February, 2026, it is hereby informed to all provisionally eligible candidates that the Written Examination for various posts under the Directorate of Trade, Commerce & Industries, Manipur shall now be held on **31<sup>st</sup> May, 2026**, as per the schedule detailed below:

i). Optional Subject is only for those candidates who had applied for the post of Project Manager (Leather)/ Project Manager (Woods work)/ Project Manager (Glass and Ceramics)/ Project Manager (Electronics)/ Asst. Mining Engineer/ Supervisor (Tech).

ii). Candidates appearing for the post of Supervisor (Technical) and Project Manager (Woodworks) are informed to submit their choice of optional paper via email: [manipurpsc.dr@gmail.com](mailto:manipurpsc.dr@gmail.com) on or before 15<sup>th</sup> May, 2026 positively. In case of failure to submit their option, the Commission will allot any of the 2 optional subjects to the concerned candidates.

2. The applicants listed in **Annexure-III(A) vide notification of even No. dated 6<sup>th</sup> February, 2026**, whose eligibility is subject to verification and confirmation of their experience certificates from the concerned Department, shall be treated as provisionally eligible as per information received from the Department of Textile, Commerce & Industries, Government of Manipur, vide letter No. ETCI-1011/2/2021-TCI-T,C&I dated 24<sup>th</sup> March, 2026. However, their final eligibility shall be subject to verification of the said experience certificates at a later date by the Administrative Department.

Further, the applicants listed in **Annexure-III(B) of the said notification dated 6<sup>th</sup> February, 2026** who were required to submit subject equivalency certificates/documents, have failed to furnish the requisite documents; therefore, their candidature stands cancelled.
