

# MANIPUR PUBLIC SERVICE COMMISSION

## NOTIFICATION Imphal, the 7<sup>th</sup> October, 2017

**No. 7/16/2014-MPSC (DR):** The Hon'ble High Court in its judgement dated 28.03.2017 passed in WP (C) No. 1020 of 2015 ordered as follows:-

"It is surprising to note that..... For appointment of Assistant Professor in respect of faculty positions in the regulations of NCTE, the requisite qualifications are one, A Master's Degree in Science/ Humanities/ Arts with 50% marks and two, M.Ed. with at least 55% marks. M.Ed. is shown to be common for all the disciplines and in case MA (Education) and M.Ed. are deemed or considered to be one and the same, there is no need of prescribing both the degrees separately as qualifications. In view of the above and in particular, the law laid down by the Hon'ble Supreme Court in the case cited herein above, this Court is of the view that the good academic record at the Master's Degree level as mentioned in the essential qualification notified vide Advt. Dated 15.11.2014 shall mean the Master of Arts in Education [(MA (Education))] and not the Master of Education (M.Ed) and therefore, the candidates possessing M.A. (Education) only are eligible for appointment to the post of Assistant Professor in the discipline of Education."

2. The candidates who did not possess Master of Arts in Education [MA (Education)] but were invited for the Interview on the strength of possessing Master of Education (M.Ed.) degree before the pronouncement of the above judgement are no longer eligible for consideration for appointment to the post of Assistant Professor in Education.

3. Therefore, in pursuance and compliance of the directions dated 28.03.2017 of the Hon'ble High Court passed in WP (C) No. 1020 of 2015, the following candidates are invited for the Interview to be held in the 3<sup>rd</sup>-4<sup>th</sup> Week of October, 2017.
