### NOTIFICATION Imphal, the 15<sup>th</sup> November, 2024

No. COMM-1/15/2021-DP-DP: In exercise of the powers conferred by the proviso to Article 309 of the Constitution and in supersession of all the existing instructions in regard to the Departmental Examinations prescribed for various categories of officers under the recruitment rules or under any other rules, regulations, orders or instructions, the Governor of Manipur is pleased to make the following rules further to amend the Manipur Civil Services (Departmental Examination) Rules, 1963 namely:-

#### 1. Short title and commencement:

- i) These rules may be called the Manipur Civil Services (Departmental Examination)(1st Amendment) Rules, 2024.
- ii)These rules shall come into force from the date of notification in official Gazette of Manipur.
