No. 7/4/2022-MPSC(DR): Applications are hereby invited from eligible candidates for direct recruitment to 13 (Thirteen) Dental Surgeon (Manipur Health Service Grade-IV) in the Health Department, Government of Manipur.

2. Period of probation: 2(two) years

3. **Eligibility Conditions:**

- The candidate must be a citizen of India
- The candidate must be able to speak Manipuri (Meetei/Meitei Lon) or any of the Tribal dialect of Manipur
- The candidate must be a permanent resident of Manipur provided that a candidate whose parent or any of his/her ancestors in his/her direct lineage are permanent resident of the State, with proper documentary proof like enrolment in the electoral roll and birth certificate will also be eligible.
- Age:** Not less than 21 years and not more than 38 years as on **23rd September, 2026** (upper age limit is relaxable by 5 years for SC/ST candidates & by 3 years for OBC candidates and 10 years for Differentially Abled Persons. Candidates belonging to SC/ST/OBC who are also Differentially Abled Persons will be eligible for grant of cumulative age relaxation under both the categories. Further, in case of Government Servant upper age limit to the extent of service rendered by them under the Govt. is relaxable.)

Note: There will be No age relaxation for the categories of candidates where there is no reservation

v. **Educational Qualifications:**

A. Possession of a recognised Dental qualification included in the First or Third Schedule to the Indian Dentist Act, 1948 as amended from time to time.

B. Registration with a State Dental Council.

vi. **Documents required to be uploaded by the candidate at the time of online application submission:**

- Class X marksheet and Certificate
- Class XII marksheet and Certificate
- Bachelor of Dental Surgery (BDS) marksheet and degree certificate etc.
- Experience Certificate (if any)
- Certificate of Registration in State Dental Council
- Category Certificate (like ST/SC/OBCs etc. certificates).
- No Objection Certificate (if applicable)
- PRC (Permanent Resident Certificate) etc.

(Domicile certificates, including any other types of residential certificates, shall not be accepted)

NOTE: CANDIDATES ARE ADVISED TO VERIFY AND ENSURE THAT ALL THE REQUIRED DOCUMENTS HAVE BEEN SUCCESSFULLY UPLOADED BEFORE FINAL SUBMISSION OF THE APPLICATION. APPLICATIONS WITH INCOMPLETE DOCUMENTS ARE LIABLE TO BE REJECTED. NO REPRESENTATIONS IN THIS REGARD WILL BE ENTERTAINED BY THE COMMISSION.

Note: 'No' queries, representations etc. shall be entertained by the Commission in respect of correcting details that are required to be filled up by the candidates by exercising due diligence and caution as the timely completion of examination process is of paramount importance.

5. **MODE OF SUBMITTING APPLICATIONS:**

The online application should be applied at www.empsconline.gov.in w.e.f. 28.09.2026, to 11:59 PM of 18.10.2026 after which the link will be disabled. Submission of application in any other mode will not be entertained. All applicants should be in possession of the requisite certificates/documents as on the date of Advertisement Notification, i.e. 23.09.2026.

Fee: Candidates are required to pay a fee of Rs. 600/- for General & OBC and for Rs. 400/- for SC & ST by using net banking, VISA/MASTER CARD/Debit Card through www.empsconline.gov.in portal. Fee is exempted for DAPs (Differently Abled Persons).

Note 1: Candidates should note that payment of examination fee can be made only through online mode as mentioned above. Payment of fee through any other mode is neither valid nor acceptable. **Application submitted without prescribed fee/mode shall be summarily rejected.**

Note 2: Fee once paid shall not be refunded under any circumstances nor can the fee be held in reserve for any other examination or selection.

6. All candidates in service shall submit/upload the "NO OBJECTION CERTIFICATE" duly issued by the concerned Department/Authority.

7. The decision of the Commission as to the eligibility or otherwise of a candidate shall be final. If on verification at any stage of the recruitment or after the recruitment, it is found that a candidate does not fulfil any of the eligibility condition, his/her candidature for the Examination will be cancelled by the Commission.

8. **SCHEME OF EXAMINATION:**

The total marks for the examination shall be 100, of which 85 marks shall be for Written Examination and 15 marks for Interview/Viva Voce.

A. Written Examination – 85 marks:

Basic Medical Science = 23 marks and

Dental Speciality subjects = 62 marks

The Written Examination will be of 2 hours duration, during which the candidates would be expected to answer 85 multiple choice questions (MCQ). The duration of the examination can be changed based on the advice of the experts with prior information to all candidates.

PENALTY FOR WRONG ANSWERS: *Candidates shall be awarded 1 (one) mark for each correct answer, and 0.33 mark shall be deducted for each incorrect answer.*

B. Viva Voce and Physical Interview - 15 marks:

The Interview will be of 15 marks, and the candidates will be assessed by a Board constituted by the Commission with Subject Expert(s). *The final merit list of the candidates would be based on the total of the written and interview marks. In case more than one candidate has the same total marks then, the candidates securing higher marks in the written examination will be ranked higher. In case both the total and written marks are same, the older (in age) candidate will be ranked higher.*

Detailed Syllabus for the examination is enclosed as Annexure-I.

NOTE:

i). The number of candidates to be called for interview will be 3(three) times the number of each category of post advertised. Candidates securing equal marks with the last candidate in written examination will also be called for interview.

ii). A candidate found to be furnishing incorrect information to the Commission, suppressing information, violating instructions, adopting various unfair means in the Examination like impersonation, cheating, etc is liable to be disqualified and/or debarred from writing MPSC Examinations as decided by the Commission.

iii). The candidature of the candidate is purely provisional subject to being found eligible in all respects.
