Irrespective of the Question Booklet Series allotted to you during the examination, claims and objections to the Answer Keys shall be submitted only with reference to the question numbers given in the **Specimen Question Booklets** uploaded on the Commission's website and enclosed herewith as **Annexure-II and Annexure-III**.

3. Only candidates who appeared in the recruitment examination for the post of Research Assistant in the Planning Department shall be eligible to submit claims and objections to the Provisional Answer Keys from **28th September, 2026 up to 05:00 p.m. on 2nd October, 2026**.

4. The following details are required for submitting claims and objections to the Answer Keys:-

- a. Application No
- b. Date of birth

5. Upon submission of the required details, the question selected by the candidate for raising a claim or objection, along with the corresponding Provisional Answer Key, will be displayed on the screen.

6. The candidate shall then select the answer considered correct and furnish a justification, mentioning details of the relevant textbook/authentic source, book title, page number, etc. Claims or objections supported by inadequate evidence are liable to be rejected.

8. Candidates challenging the Provisional Answer Key(s) shall pay a fee of **₹300/- (Rupees Three Hundred only) per question through online mode.** The payment link will appear before the final submission of the objection(s).
9. No other mode of submission of objection(s) or payment of the prescribed fee shall be entertained, except through the weblink provided above.
